Founders Day Dinner a Success

Gathering Brings Together Alums and Actives



On March 10, the Michigan Alpha Alumni Association and the active chapter membership held a Founders Day dinner celebration at the Michigan League on central campus after a brief open house at 1437 Washtenaw.

“The active chapter membership did a fine job of hosting this event. I think the alums who attended found the dinner to be very enjoyable. It was an excellent opportunity to visit the house, renew old friendships, meet the active members and support the principles of the fraternity,” said General **John Buck '54**.

The event, attended by 14 alums and 45 active members, featured state of the fraternity reports from Alumni Association President **Rex Vaughn '74** and Michigan Alpha President **Patrick Moore '09**. It also featured remarks from the director of the University of Michigan Office of Greek Life.

The evening was capped off by a traditional Phi Delta Theta ritual that paid tribute to the Founding Fathers while explaining the purposes and values of the fraternity.

In 1910, the Phi Delta Theta General Headquarters established Founders Day on the birthday of Robert Morrison to honor our fraternity's six Founding Fathers.

Michigan Alpha re-established its tradition of holding an annual Founders Day event during 2006 when **Charlie Green '58** facilitated the availability of the U of M Golf Course club house for a dinner event.

“This year's event built on the success of last year. The alumni response has been encouraging and we believe the Founders Day dinner has momentum to be a bigger event next year with a prominent guest speaker. The active chapter members greatly enjoyed meeting and talking with alums both at the house and during dinner. I think this is a great way to demonstrate to the actives that Phi Delt is a fraternity for life,” said Vaughn.

This support comes right in the time to help the Alumni Association to meet the never ending challenge of physically maintaining our 104-year-old historic house, improving alumni services and communications, and supporting the efforts of the active chapter to re-establish Michigan Alpha's tradition of excellence on campus. As you will read in the report by active chapter President **Patrick Moore '09**, Michigan Alpha is making substantial progress and deserves our support.

You can rest assured that every dollar contributed to the Annual Fund will be spent wisely. The Alumni Association will use a portion of these funds to undertake important projects at the house based on our capital improvement plan while also enhancing the alumni program services. After Treasurer **Joe Kraus '82** certifies that we have balanced our budget, Vice President **Joseph Fattore '80** will judiciously invest Annual Fund money in accomplishing high value projects.

Since Michigan Alpha was formally reestablished on campus in December of 2004, it has been the chapter's goal to reestablish our traditional reputation as a leader among fraternities on campus. As our legendary brother **Bob Ufer '43** was fond of saying, "What the mind can conceive, the man can achieve."

In this regard, we have conceived and achieved carrying on as a fraternity at the University of Michigan that is second-to-none in terms of balancing academics, leadership opportunities, social responsibility and the pursuit of an enjoyable collegiate experience that will create lifelong friendships.

Now that I've provided an overview of the "big picture," I like to inform you about some specifics that made Michigan Alpha's

122nd year on campus truly memorable.

To start the year off right, a strong crew of active brothers made that traditional Wolverine pilgrimage to the Rose Bowl. Despite the disappointing outcome of the game, the brothers enjoyed the sunshine and Southern California hospitality that made the trip well worthwhile.

Winter pledge recruitment kicked off early in January and ended with six new Phikeia who were quickly plunged into the busy life of earning the right to become a Phi. The same month also included a skate night and party with Delta Gamma sorority which was followed shortly thereafter by our first ski trip to Nub's Nob in northern Michigan.

Valentine's Day came around all too quickly and the men of Michigan Alpha broke some hearts after improving our relations with a few of our favorite sororities. The month was also filled with Wolverine basketball home games where our enthusiastic cheering for the team garnered attention on TV and the Michigan basketball web site. Spring break capped February with many brothers splitting into contingents that enjoyed a break from the books in either Savannah, Georgia or Las Vegas.

March was our busiest month of the semester. Brotherhood events included an opening night viewing of the inspiring movie "300" as well as the many various and exhausting Greek Week preparation events leading up to the actual week of competition at the end of the month. Our partners for this year's Greek Week included Delta Gamma, Alpha Phi Alpha (NPHC), and Theta Chi.

During the week of competition we brought home the Greek Olympic championship, took first place in the Anchor Splash water competition, made an impressive performance by both sing and variety teams, and achieved a second place finish in overall blood donations.

Our annual ALS Walk n' Roll, which was held at the end of March, was certainly one of the highlights of the year. This event proved to be the most successful philanthropy event in the history of Michigan Alpha. We raised donations totaling more than \$18,000 to help combat a disease that claimed the life of Brother Lou Gehrig (Columbia University '25) and

old friends in the house.

Phi Delta Theta founder Robert Morrison famously once said, "To do what ought to be done, but would not have been done unless I did it, I thought to be my duty." The Alumni Association is extremely gratified that the brothers have demonstrated Morrison's philosophy of personal action by answering our call to action. We fully appreciate the fact that you have many important demands and worthy causes for which to allocate your hard earned money.

Whether you made a modest or a major donation, every dollar contributed to the Annual Fund helped to make this year's fundraising a record success. Our Annual Fund donor team featured 130 members (see their names on page 6) who contributed \$22,375 this year - a new record! I am particularly pleased that this achievement is representative of a trend that started with the reestablishment of the active chapter in 2004.

Contributions to the 2005-2006 Annual Fund (\$14,600) grew by 17% over the donations to the 2004-2005 Annual Fund (\$12,460). This year's Annual Fund enjoyed an astounding 53% increase over the previous year as we smashed through our ambitious \$20,000 donation goal to reach \$22,375.

While the total numbers are impressive, the real success story is that the brothers care enough about this fraternity to make a difference. I would like to offer a special word

of thanks to **Peter Gutman '85** for making this year's top single contribution of \$2,500. I would also offer praise for my pledge classmate **Stephen S. Clark '74** for making a \$1,000 contribution for the second year in row.

The Alumni Association is very grateful to the eleven brothers who made donations at the Robert Ufer Level (\$500 - \$999): **Roger B. Smith '46, Richard Young '51, Douglas Roby '56, Robert Sommer '57, Richard Worsham '67, Mark Hopkins '76, Carl Annessa '79, Michael Levitt '80, Alexander Rothrock '81, Jordan Dickstein '84, Paul Lamoureux '85 and Greg Karmazin '87.**

As good as the news is this year, the Alumni Association will not rest on our laurels. Over the summer, we plan to evaluate ways of encouraging greater numbers of brothers to participate in the Annual Fund. The growth in the amount of contributions collected is outstanding; however, we still only have about 12% of all brothers giving to the Annual Fund. I would like to see this number grow to at least 20% during the 2007-2008 Annual Fund.

Another important task for the Alumni Association is to evaluate potential strategies for paying down our \$400,000 long-term debt that financed the major renovations during the early 2000s that played a critical role in saving the house from potentially irreversible physical decline while reestablish-

ing the active chapter membership during the 2003 and 2004 school years.

We simply cannot leave this long-term financial burden to a future generation to resolve. The summary of my report this year is that the Alumni Association's finances are stable and headed in the right direction, but our overall situation remains vulnerable to reversals because of the long-term debt load. Although it would be challenging to accomplish and I'm uncertain about whether or not the brothers would support this concept, I think we should explore the feasibility of establishing a multi-year capital campaign at some point. **Doug Roby '56** and **Greg Karmazin '87** have volunteered to organize some preliminary thoughts about this concept for the Alumni Association.

They are evaluating the results of the 2006-2007 alumni survey to gauge the level of interest in such an endeavor. I wish to thank all the brothers who took the time to fill out this first-ever survey which is yielding very helpful information about your opinions and priorities for the Alumni Association.
